SECTION 4: First aid measures

4.1 Description of first aid measures

- Protection of first-aiders : When administering first aid, ensure that you are wearing the appropriate personal protective equipment according to the incident, injury and surroundings.

4.2 Most important symptoms and effects, both acute and delayed

- Local necrosis is evidenced by delayed onset of pain and tissue damage a few hours following injection.

4.3 Indication of any immediate medical attention and special treatment needed

seriousness of the underlying damage, surgical exploration to determine the extent of involvement may be necessary. Local anaesthetics or hot soaks should be avoided because they can contribute to swelling, vasospasm and ischaemia. Prompt surgical decompression, debridement and evacuation of foreign material should be performed under general anaesthetics, and wide exploration is essential.
